42.14 SENSORY GARDEN. (Agenda Item 7)

The Sensory garden is need of some maintenance and clearing work to make it look inviting to the public again. The gate is broken and there is a need for a proper pathway to allow for wheelchair access.

It was agreed that some work should be done to the garden and that money is available for this. A schedule of works would need to be drawn up and work undertaken as soon as is possible.

The young adults from the Social Action Project have been in the Town since the 11th August and have been refurbishing the Bus shelter's on Queens Square and Cyprus Road, as well as re painting some play equipment at the recreation ground, weeding the rose garden at the church yard and being involved in finishing the Graffiti wall at the Skate Park. They have done more than was intended and have made an excellent job of enhancing the Town. Council are very happy with their work and the way have they conducted themselves over the time they have been here.
