  would need to come in to rectify. Cllr Ellis also informed the meeting the
  company who maintains the public toilets has gone into receivership.
- Cllr Oliver reported he had written to Fair Trade and would like to peruse Attleborough Town Council becoming a member. Council agreed that Cllr Oliver could pursue this
- Cllr Sam Taylor mentioned that the dog bin had not yet been placed on site at 6 Connaught Road she also asked it a second dog bin could be installed on Thieves Lane towards to the junction of Besthorpe Road. Cllr Taylor asked that the clerk write thank you letters to the boxing club for their help in planting the bulbs round Queens Square and also asked a letter to be written to the SNAP team expressing thanks for a quiet Christmas with regards to antisocial behaviour in the Town Centre. Cllr. Sam Taylor enquired about the progress of the railings in Queen Square and was told Andrew Gayton Historic buildings Consultant had emailed today confirming he has no objections.

# 160.14) Attleborough Neighbourhood Plan

  - Website now up and running.
