193.14) Councillors Reports

Reports were received as follows:-

Cemetery -

 Cllr S Taylor reported that she had carried out some planting of rose bushes at the cemetery with Cllr Crouch. The Groundsman had also planted some hedging and the new area would hopefully be ready in the near future

Railings, Queen's Square -

- Cllr S Taylor reported that Cllr Pettitt had brought up that her expectation for the new railings in Queen's Square was that every so many posts would be a built-in standard not a post added to the railings. The standards would be used to take hanging baskets and the Christmas lights. If the contractor was meant to be replacing like for like then Cllr J Taylor had raised concern regarding the quality of the steel and if they would be strong enough to support the weight
- Cllr S Taylor advised that she had approached Bodo and they would make alternative brackets at a cost of £4,000 to enable the standards to be attached in a different design format
- Cllr Pettitt advised that the Conservation Planning Officer had approved the replacement railings on the understanding they would be returned to their original historic design and to make significant changes would require a full planning application
- Cllr Oliver raised concern that the contractor could sue for breach of contract if prevented from completing the contracted works
- Cllr Ellis stated the contractor would need to be paid the agreed sum even if the Council decided not to complete the work agreed and Cllr J Taylor agreed that the full sum should be paid
- Cllr Ashby stated that he had visited the Town Council office last week and felt there had been a lot of stress and pressure caused because of the controversy over the railings project and that this was not acceptable for the Office staff
- The Clerk raised concern that altering the contractor's design or modifying the railings may invalidate any insurance cover from the contractor and asked if "Bodo" would accept ongoing liability.

On the motion of Cllr S Taylor, seconded by Cllr J Taylor, it was **RESOLVED** that this contractor removes the silver clips and finished the lower railings with welds and Attleborough Town Council will re-address the standards at a later date

Cllr Pettitt referred to the tabled diary and reported on the month's events; she was pleased to report that she had raised £3,000 for her chosen charities which would enable her to present £1,500 to each charity. Members thanked the Mayor for all her efforts with fund-raising during her term in office. Cllr Pettitt thanked the councillors for all their support and wished them luck in the forthcoming elections

b) County and District Councillors -

District Cllr Stasiak – Approaching elections and nothing to report but commented that the Town Council were fortunate no members of the press had been present to report on tonight's meeting

District Cllr Martin – Offered apologies for District Cllr North and reported she had received an injury and wished her a fast recovery. Cllr Martin had attended 2 meetings; an all-day sub-committee which he felt resulted in the right decision for the Police, etc. Neighbourhood Plan meeting at Dereham and was disappointed that there were no representatives from Attleborough other than him. Presentation from Cringleford and as development progresses Norfolk County Council is paid and he may raise this regarding the link road

Clir Crouch – Reported that he had 6 volunteers for the proposed Community Speedwatch and the paperwork has been signed and training will start once this is processed

196.14) Attleborough Neighbourhood Plan

a) To receive an update on progress -

Cllr Tyrer gave a verbal update which included the following:-

- All objectives are being developed and supporting draft policies
- · Meetings with retailers and business forum
- Will discuss findings, sports and leisure report and health and social care is being undertaken
- Meeting consultant for Tarmacadam and looking at developing transport schemes and considering what needs to be prioritised for the Town
- Meeting with Heritage group and looking at how Attleborough has developed over the last 100 years
- This is a pivotal period for the Town and Attleborough Town Council and if they fail to get this right and do not invest, opportunities will be lost both politically and in getting facilities for the Town's needs now and in the future
- Likely to be requiring £40 60,000 in funding to complete the Neighbourhood Plan
- If we do not have a plan and identify significant needs then Breckland will find it difficult to negotiate with developers to identify any community schemes for \$106 money
- Does Attleborough Town Council want to "step-up" and be professional or not? It is a significant change to how they should be operating to make this one of the best places in Norfolk, or not, which is the other option
- Local enterprise study is keen to look at Attleborough and how developers are working with the steering group and will put Attleborough on the map, in a good place but very challenging issues coming up
- Thanks were expressed to the Town Council office staff and Miss Dewsbury for her efforts in seeking grant funding

Several members expressed their support for the Neighbourhood Plan and the work of the Steering Group

b) Request from Mr Cracknell - (Cllr Tyrer left the room for this item)
Correspondence from Mr Cracknell regarding funding of the Neighbourhood Plan
was discussed. The Clerk was instructed to write to Mr Cracknell and express
appreciation for his funding to-date and advise that if the Council can reclaim any
money back they will but it is not possible to refund the money at this time.

c) Proposed new website agreement - quotes -

Members considered Mr Kilby's comments made in "Public Participation" and Cllr Tyrer's update. Cllr Ashby stressed that the office staff should be supported and not have more work put on them and the Clerk advised that the staff may need some training if the site was changed. Cllr Ellis questioned why there was a need for a new site and, if so, why the Steering Group could not have an independent site and the Council site be retained.

On the motion of Cllr S Taylor, seconded by Cllr Ashby, it was

RESOLVED that the GML contract be accepted and approved on the condition that there is no publicity for traders, that the Council office are in control of the site and that there is a separate page for businesses.

Public Participation Notes

The Chairman invited members of the public to speak and comments received included the following:-

- A resident reported that they had visited the Dell and had found hardly any litter at the site and was happy to let her dog off
- A resident complimented the members on the work being done in Queen's Square to replace the railings and stated that it looked "really good"
- Mr Kilby spoke on behalf of the Neighbourhood Plan Steering Group and outlined the importance of an upgraded website and recommended the new agreement with GML. He stressed that on launching the "Attleborough Matters" magazine it was vital that feedback could be recorded. He confirmed that the Town Council would retain the domain name and the Town Clerk would be in full control of the site. He advised that when he initially became involved with the Steering Group the Council had a different website which was upgraded and this was donated by one of the group's members, however, this funding would now cease. The new agreement would cost £150 per month and annual hosting of £220 per annum
