# a) Premises Licence renewal -

(Cllr S Taylor and Cllr T Taylor left the meeting during this Item)

Mr Andrew Grimley, Environmental Health Officer from Breckland District Council was in attendance and informed the Council that he had received some complaints regarding the Summer Carnival held at the Recreation Ground.

Main concerns were regarding noise levels from the tannoy system, the loud level of music and the noise from the running of generators.

Mr Grimely stated that he had received a petition from 6 members of the Public. The Clerk advised she was unaware of this petition, however, there had been a great deal of liaison between the Breckland licensing team and the Council staff. Mr Aghabi was also surprised by this information and had no previous knowledge of the petition and this was reiterated by Mr Cossey and council members. Mr Aghabi and Mr Cossey stated that they would take the concerns to the Carnival Committee for consideration at future events.

Following a short discussion; it was felt that an informal meeting take place with Mr Aghabi, Mr Cossey, Cllr Dale, Cllr Burton, Mr Grimley and a member of the Breckland Council Licensing Team to answer any queries to take this forward as no one from the Licensing Team had been available at this meeting.
