## **EN038.17) Review of Exclusive Rights Fees**

## **EN039.17) Fireworks Update**

An email containing advice from the Town Council's insurance company was circulated and short discussion took place; points raised included:

- If the display is handled by the Fun Fest Team then they would have to accept all liability and the Town Council need to receive copies of Public Liability Insurance, Risk Assessment and all relevant paperwork pertaining to a Firework Display event. Any funding towards the cost of the fireworks would be by donation from the Town Council and a financial breakdown and copy of the invoice to be requested.

- Cllr Burton advised he had been invited to a meeting of the Fun Fest Team on Tuesday, 20 February, and suggested other members may wish to attend

## **EN040.17) Disabled Access to Gaymers Meadow**

Following consideration of photograph of resident on mobility scooter a short discussion took place; points included:

- As Gaymers meadow is a field, access during this time of year is likely to be problematic, especially if designated access is not used.
- The Meadow is an open space and there is no formal (surfaced) path
- Grounds staff are putting down sand to improve the muddy entrances; a suggested option was to consider alternative surfacing such as rubber matting.
- The Clerk has contacted the Football Club and asked them to consider resolving the drainage of surface water from their mobile unit directly onto the field.

On the motion of Cllr Dale, seconded by Cllr S Taylor, it was

**RESOLVED** to have a meeting on site with the Groundsmen, the Clerk and interested Environment Meeting Committee Members to discuss the horticultural management of Gaymers Meadow.

# **Public Participation Notes:**

The Chairman invited members of the Public to speak and points raised included the following:

- Resident commented shift workers are still parking at Gaymers car park causing a nuisance during middle of night and enquired about putting a gate across entrance - a consultation regarding possible night closure of the area is planned
- The Town Council is awaiting legal advice regarding possible parking restrictions and a letter will be sent to Banham Poultry and some members attend their meetings
- Resident queried the planned parking restrictions on Queen's Square car park confirmed that this area is owned by Breckland District Council and the parking restrictions will be implemented later this year.
- Reference made to the difficulty of access for a disabled user and noted as on the agenda
- Resident enquired if there were plans to extend the football pitches from the Recreation Ground to Gaymers Meadow - Councillors responded as part of the future Masterplan there may be additional land allocated for football.
- A discussion followed about the pitch within the running track being used for football and nine different age groups playing football.
- A football club member reported good communication taking place between the football club and responsible dog walkers to resolve any issues
