06.16) Minutes of the meeting held on 24 November 2015

07.16) End of year accounts

End of year reports -

The end of year reports were considered and discussed by members and balances noted. The Clerk confirmed that RBS had concluded the year end process and that the internal auditor would attend on 25 May 2016 to carry out the internal audit. The financial reports would be presented at the following full council meeting and the annual return would then be submitted to the external auditor, Mazars, for inspection and approval.

Members reviewed the budget figures and there was some discussion.

The Clerk was requested to investigate interest rates for members to consider reinvestment of the funds held in the charity account.

The reduced income from the Market was noted and members expressed concern; the Clerk confirmed that Mr Morfey (NP Planning Consultant) had suggested promotion of the Market and office staff were investigating the use of funds from the Market Towns Initiative for this project.

09.16) Scout lease document

Lease – for review

Members considered the Scout lease and after discussion were happy to renew for the same term.

On the motion of Cllr Ellis, seconded by Cllr Dale, it was

RESOLVED to renew the Scout lease with the same terms as before subject to any amendments made by the Solicitor, the Clerk to forward to Carl Heywood for review and then to issue

Cllr Ellis asked members to consider appointing a different Solicitor and the Clerk suggested that it may be prudent to wait until the current leases were finalised for the sake of continuity; this item could be placed on a future agenda for full consideration.

Mrs Willett (Clerk's Assistant) confirmed the current status of all the Council's leases and advised that three were still outstanding as the Solicitor was processing same. Once finalised by the Solicitor these leases would be issued to the tenants for signature
