**b) Proposed bus shelter, London Road/Dodds Road** – Recent correspondence from Helen Martin, Norfolk County Council was discussed. The Clerk confirmed she had also spoken to Ms Martin regarding the structure of proposed shelter and had been advised that the shelter would be provided under a S.278 agreement which worked in a similar way to the usual S.106 agreement although the Developer would provide the shelter and place the order instead of NCC. The members would have an opportunity to express their preference regarding structure and design but it was too early in the process to confirm at this time. There was a suggestion to opt for a brick and tile construction rather than the Perspex type which was considered more vulnerable to vandalism. Further suggestion that members could meet with the developer to discuss options.

# Public Participation Notes

The Chairman invited members of the public to speak and comments received included the following:-

Dist Cllr North reported that she had witnessed lots of activity at the former Grampian food site and workmen on site recently

Isabel Lockwood acting for Raemoir Properties outlined proposals for the former Grampian food site, Buckenham Road –

- The site closed in 2008 and has since been redundant
- The site is 5.4 hectares
- Technical infrastructure and capacity of site needs to be considered
- The opportunities and constraints around the site; also hedges and important views
- Traffic and Transport there has been a number of assessments over the years and trying to find solutions
- Have been reviewing the network with LEP and also talking to Norfolk County Council - looking at opportunities to improve the town centre gyratory but no conclusions yet
- Would like to hear Attleborough Town Council's comments
- As a former factory there are some contamination and remedial costs
- Approx 160 houses proposed
- Concern that there was an issue down White House Lane with water and subject to flooding developer is aware and likely that mitigation is required
- Councillors requested that all proposals are taken forward with the Neighbourhood Plan Steering Group
- Suggestion that there is a need for key-worker homes instead of more affordable housing the mix and nature depends on what the market demands and there is a need to find a balance and this is sometimes contentious between the housing officer/department and the local council
