### **Public Participation Notes**

The Chairman invited members of the public to speak and points raised included the following:

- A Resident asked if it was correct Warrens Lane was not viable as a burial site and therefore if the planning application would continue.
   It was confirmed by Cllr Bond a Survey was undertaken which confirmed this to be the case. The CEO confirmed she had spoken to the Breckland District Council Case Officer.
- A Resident queried whether there were any designated plans for Gaymers Meadow.
   Members responded the Attleborough Neighbourhood Plan includes aspirations for
   Gaymers Meadow to become a Sports Hub; it is hoped to extend the existing
   meadow to include a section of land which is not yet available; this will come under
   the SUE as part of the strategic framework within the Attleborough Neighbourhood
   Plan.
- A Resident asked for:
  - A definition of 'Open Space' and was it the same as the 'Linear Park'?
  - The location of the Sports facilities?
  - Were the Consultants the same as used before?
  - The fees for the Consultants?

Cllr R Bond responded, the Sports Provision and the SUE was being handled by Ian Barclay and the smaller Play Areas by Phil Doyle. The day rates for the Consultants are between £400-500 per day.
