ENV065.18) Minutes of the Environment Committee meeting held on 21 January 2019

The minutes of the meeting held on 21 January 2019 were noted. Cllr Dale asked for an update on drainage at Football Club building. The solicitor is investigating a previous lease and members agreed to postpone the remedial work until this was clarified. In the interim the Groundsmen would improve the entrances at Gaymers Meadow to assist access; suggest using sharp sand.

ENV066.18) Open Spaces

a) **London Road Play Area Master Plan** - the CEO asked Councillors if they wished her to pursue potential S106 money for London Road as on previous discussion with Breckland the plan showed a different area of land

On the motion of Cllr Dale, seconded by Cllr Bond, it was

RESOLVED the CEO requests Breckland Council to reallocate the S106 funds to the London Road play area and for Mr Doyle, Consultant, to be instructed to assist.

b) **Existing S106 Funds** - the CEO reported it was very positive to receive confirmation from Breckland Council of S106 funds for a total £235,966.41. Currently trying to define money available and for which sites. Blackthorn Road potential transfer of land was discussed and requirement from Breckland Council for a masterplan before

any transfer would be considered. Cllr S Taylor queried £9,980 funds and requested an application be submitted as soon as possible.

On the motion of Cllr Dale, seconded by Cllr S Taylor, it was

RESOLVED the CEO instruct Phil Doyle, Play Consultant to progress the masterplans for all areas, including Blackthorn Road, and liaises with Breckland Council to release the S106 funds available.

c) Electrical Connection to Cemetery and Chapel update – Progress to date was noted and it was suggested assistance is sought from Norfolk County Cllr Rhodri Oliver to progress the project.
