## NORFOLK COUNTY COUNCIL (ATTLEBOROUGH) TEMPORARY TRAFFIC RESTRICTION ORDER 2018 ROAD TRAFFIC REGULATION ACT, 1984 SECTION 14(1)

ORDER temporarily restricting the use by vehicles of the:-

- 1) B1077 Exchange Street from its junction with C572 High Street to its junction with B1077 Queens Square (hereinafter referred to as the said road (a));
- 2) B1077 Connaught Road from its junction with B1077 Surrogate Street to its junction with C572 High Street/ B1077 Connaught Plain (hereinafter referred to as the said road (b));
- 3) B1077 Connaught Road from a point 68 metres west of its junction with B1077 Surrogate Street/Station Road to its junction with C572 High Street/B1077 Connaught Plain (hereinafter referred to as the said road (c));
- 4) C572 High Street from a point 100 metres west of its junction with B1077 Connaught Plain/Exchange Street to its junction with B1077 Connaught Road/ Connaught Plain/ Exchange Street (hereinafter referred to as the said road (d)); and
- 5) B1077 Exchange Street from its junction with C572 High Street for a distance of 35 metres eastwards; (hereinafter referred to as the said road (e));

## in the TOWN OF ATTLEBOROUGH

- 1. Save as provided in Article 2 of this Order and whereas the Norfolk County Council as Traffic Authority for the Administrative County of Norfolk is satisfied that carriageway resurfacing works are required at the said roads (a) (b) (c) (d) and (e) in the TOWN OF ATTLEBOROUGH and that in consequence with effect between 19:00 and 06:00 hours from 28<sup>th</sup> October 2019 to 30<sup>th</sup> October 2019 for the duration of the works:-
  - (i) traffic over the said road (a) should be subject to a temporary suspension of the one-way system (southbound) to allow vehicles to travel in both a northerly and southerly direction;
  - (ii) traffic over the said road (b) should be subject to a temporary suspension of the one-way system (westbound) to allow vehicles to travel in both a westerly and easterly direction; and
  - (iii) traffic over the said roads (b) (c) (d) and (e) should be prohibited.
- 2. Nothing in Article 1 of this Order shall make it unlawful for a vehicle which requires access, to proceed to a final destination situated within the length of road specified in Article 1 of this Order.
- 3. This Order has a maximum duration of 18 months and will be revoked upon completion of the works. Where exceptional circumstances are encountered during the performance of the works specified in this Order the operational period of this Order may become extended to allow completion of the works after obtaining consent of the Secretary of State.

NOW THEREFORE the Norfolk County Council DO HEREBY ORDER, that with effect between 19:00 and 06:00 hours from 28th October 2019 to 30th October 2019 for the duration of the works the said roads (b) (c) (d) and (e) SHALL NOT BE USED by any class of vehicle and the said roads (a) and (b) SHALL BE SUBJECT to a temporary suspension of the one-way restrictions (southbound and westbound respectively).

The road 1) will be temporarily subject to a suspension of the one-way restriction (southbound); the road 2) will be temporarily subject to a suspension of the one-way restriction (westbound); and the roads 2) 3) 4) and 5) will be temporarily closed (except for access) between 19:00 and 06:00 hours from 28th October 2019 to 30th October 2019 for the duration of the works.

Alternative HGV route is via: B1077 Surrogate Street/ Norwich Road, A11, B1172 Spooner Row slip/ London Road/ Station Road, A11, C572 London Road/ High Street;

(For Queens Road) B1077 Surrogate Street/ Norwich Road, B1172 London Road, A11, B1077 Queens Road/ Exchange Street;

Alternative LGV route is via: C572 High Street/ London Road, A11, U33119 Blackthorn Road, B1077 Queens Road/ Exchange Street (Attleborough/ Wymondham).

(If necessary the restriction could run for a maximum period of 18 months from the date of the Order).

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
