a) 'Attleborough Station; Proposed Car Park Development' by Joanna O'Donnell, Head of Projects, Kieran Gallagher, Project Manager and Mike Arthur, Director (MAD Design)

After initial introductions Joanna O'Donnell outlined plans for proposed car park development. Currently only 30 spaces at the moment, by 2026/27 an increase of up to 50% passengers using the train station and current proposal would provide 86 parking spaces. The plan shows 2 buildings they can remove building No 1 but they have been asked to retain building No 2 which would result in the loss of 12 car parking spaces, if any trees are removed they would be replaced within the planned landscaping. Cllr Busk asked what costs would be charged to park and it would involve Number Plate Recognition. It was queried whether Greater Anglia have communicated with the District and County Councils and confirmed they have been in discussions with both.
