

NORFOLK COUNTY COUNCIL proposes to make a Temporary Traffic Order affecting the road from Snetterton to Old Buckenham for 20 metres either side of the rail crossing in the PARISH OF QUIDENHAM because of lining works on rail level crossing.

The road will be temporarily closed (except for access) from 23:00 hours on 11th February 2020 to 06:00 hours on 12th February 2020 for the duration of the works, expected to be 1 night within the period.

Alternative route is via: Road From Snetterton To Old Buckenham, Stone Cross Interchange, A11, London Road, B1077 High Street/ Connaught Plain/ Exchange Street/ Queens Road/ Queens Square/ Church Street/ Surrogate Street/ Station Road/ Buckenham Road/ Attleborough Road/ The Green, Hargham Road (Old Buckenham, Attleborough, Quidenham).

(If necessary the restriction could run for a maximum period of 18 months from the date of the Order).

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.

In the event of the start date being delayed the new start date will be displayed on site in advance.

NORFOLK COUNTY COUNCIL (QUIDENHAM) TEMPORARY TRAFFIC RESTRICTION ORDER 2020 ROAD TRAFFIC REGULATION ACT, 1984 SECTION 14(1)

ORDER prohibiting the use by vehicles of the road from Snetterton to Old Buckenham for 20 metres either side of the rail crossing in the PARISH OF OUIDENHAM

- 1. Save as provided in Article 2 of this Order and whereas the Norfolk County Council as Traffic Authority for the Administrative County of Norfolk is satisfied that:-
 - (i) Lining works on rail level crossing are required at the road from Snetterton to Old Buckenham for 20 metres either side of the rail crossing in the PARISH OF QUIDENHAM (hereinafter referred to as the said road) and:
 - (ii) that in consequence traffic over the said road should be prohibited with effect from 23:00 hours on 11th February 2020 to 06:00 hours on 12th February 2020 for the duration of the works expected to be about 1 night within the period.
- Nothing in Article 1 of this Order shall make it unlawful for a vehicle which requires access, to proceed to a final destination situated within the length of road specified in Article 1 of this Order.
- 3. This Order has a maximum duration of 18 months and will be revoked upon completion of the works. Where exceptional circumstances are encountered during the performance of the works specified in this Order the operational period of this Order may become extended to allow completion of the works after obtaining consent of the Secretary of State.

NOW THEREFORE the Norfolk County Council DO HEREBY ORDER, that with effect from 23:00 hours on 11th February 2020 to 06:00 hours on 12th February 2020 for the duration of the works the said road SHALL NOT BE USED by any class of vehicle.
