Hi

I turned up at 7am at Gaymers Meadow main car park off the industrial estate, to find strewn across the floor:

- 1) Polystyrene take away containers (can only be from the Hi her Hut mobile food van parks outside old Brantaq facility by railway station).
- 2) Beer bottles and cardboard pack wrappers x 2 and tobacco pouch just left in middle of tarmac, some bottles thrown by fence and broken.
- 3) Smashed glass all across area to right as you enter and on hedge side.

I have cleared as much up as I could, but we are seeing early evening times a couple of cars with late teenagers in, eating, drinking and smoking cannabis.

There are regular small groups if 2-6 Young people at a time who sit on the benches (far side/by field in both sections of Gaymers Meadow to smoke cannabis.

I'm not sure what can be done as the Police regard this as low level and are likely to respond.

Not sure if the council has any ideas on how if anything can be done to cut this down.

Dear Attleborough town council

I recently came onto my allotment plot xxxxxx to discover that my plum tree has been severely pruned back. I have no proof of who did this but i suspect that it is the neighbour (xxxxxxxxx) as i do not believe it in anyone else's interests to do this. I do not object to someone wanting to cut back any branches that over hang their plot. What i do object to is someone coming onto my without prior permission (no permission has been sought from Mr xxxx. I have hardly had a conversation with him.

Not only have overhanging branches been cut but the tree has been severely pruned into the trunk (please see photographs).

I believe that Mr xxxxxxx has not the right to step onto my allotment without due permission to carry out work. The tree has been damaged and so a good portion of crop has been lost. This is not the first time this has happened. I emailed you about a situation last year about the same tree. After an initial email back to me there was no suggestion of what you had intended to do. I would like to know how you intend to deal with this?

I have not approached Mr xxxxxxxxx as i want to go through the correct channels.

I expect to hear from you within the week as you will appreciate i am not happy.

Email from Allotment Holder (second))

Good afternoon,

I got down to my allotment early before work this morning at about 6.15am. I have been unable to get down there recently worker working full time and having to do the cooking, cleaning, shopping etc. At around 7.30am after taking a break from doing some much needed weeding and about to fill my watering can I was approached by who said, "Did your friend tell you why I called him a cunt?"
To put this into context I believe he was referring to a conversation he had had with earlier this week when had used the c-word against Mr after Mr enquired about the pruning of the cherry tree.
I told him I did not want to discuss that issue saying that it has nothing to do with me. He then repeated his initial question with a similar one. Again using the c word. I told him again that I didn't want to discuss it with him. He tried again. I told him "please to stop as I find the word offensive."
I do not understand why he continued to provoke me to try and get a response. It was as if he wanted an argument and I was there to work and relax at the allotment.
He also started to quote something from the Bible and asked me to tell this to didn't want to get drawn into this conversation.
We then discussed the use of the c-word and he said it is a word in the Queens English and he doesn't mind using it. I asked if he'd use it in public and he said yes. I asked if he'd use it in front of my 8 year old son. And he said "Of course not".
He then said he used the c word towards "to deliberately cause offense".
I'm afraid then I raised my voice and told him what I thought about the situation. Saying that deliberately using the c-word was just nasty. He seemed to enjoy the fact he had finally got a reaction out of me.
I then reminded that the last time I was at the allotment () that I knew Mr was working more hours than normal to support vulnerable people during the COVID outbreak which was why he hadn't found as much time as he'd like to come to allotment. I then told that if he wanted the cherry tree pruning back then he could have talked to me to see if I could pass on the message.
I also let him know that going onto someone else's allotment is against the allotment rules. Chopping down branches of a fruiting tree is certainly against the rules. I also said I'm sure swearing at your allotment neighbour is against the rules.
I understand that you send warning letters to people if they breach the rules. I would request that you do so in this case in all haste.
I had planned to go to the allotment this evening with my family I will try to get down there but I am now fearful that will be there and bring all this back up again. I found him very intimidating.
