



NORFOLK COUNTY COUNCIL (BESTHORPE) TEMPORARY TRAFFIC RESTRICTION ORDER 2020 ROAD TRAFFIC REGULATION ACT, 1984 SECTION 14(1)

ORDER prohibiting the use by vehicles of the C139 Bunwell Road from its junction with the U33092 Whitehouse Lane to a point 68 metres south of its junction with the C139 Besthorpe Road in the PARISH OF BESTHORPE

- Save as provided in Article 2 of this Order and whereas the Norfolk County Council as Traffic Authority for the Administrative County of Norfolk is satisfied that:-
 - (i) Rail inspection through the level crossing and track maintenance works are required at the C139 Bunwell Road from its junction with the U33092 Whitehouse Lane to a point 68 metres south of its junction with the C139 Besthorpe Road in the PARISH OF BESTHORPE (hereinafter referred to as the said road) and:
 - (ii) that in consequence traffic over the said road should be prohibited with effect between 23:45 and 05:45 hours from 19th September 2020 to 20th September 2020 for the duration of the works expected to be about 1 night within the period.
- Nothing in Article 1 of this Order shall make it unlawful for a vehicle which requires access, to proceed to a final destination situated within the length of road specified in Article 1 of this Order.
- 3. This Order has a maximum duration of 18 months and will be revoked upon completion of the works. Where exceptional circumstances are encountered during the performance of the works specified in this Order the operational period of this Order may become extended to allow completion of the works after obtaining consent of the Secretary of State.

NOW THEREFORE the Norfolk County Council DO HEREBY ORDER, that with effect between 23:45 and 05:45 hours from 19th September 2020 to 20th September 2020 for the duration of the works the said road SHALL NOT BE USED by any class of vehicle.
