

NORFOLK COUNTY COUNCIL (QUIDENHAM AND OLD BUCKENHAM) TEMPORARY TRAFFIC RESTRICTION ORDER 2021 ROAD TRAFFIC REGULATION ACT, 1984 SECTION 14(1)

ORDER:

- prohibiting the use by vehicles of the C138 Road from Snetterton to Old Buckenham from a point 15 metres east of its junction with the C153 Hargham Road to a point 515 metres west of its junction with the U33129 Heath Road in the PARISH OF QUIDENHAM (hereinafter referred to as the said road (a));
- imposing a temporary suspension of the 7.5 tonne weight restriction on the C138 Road from Snetterton to Old Buckenham from its junction with the C153 Station Road to a point 167 metres east of its junction with the U33043 Church Road in the PARISH OF QUIDENHAM (hereinafter referred to as the said road (b)); and
- imposing a temporary suspension of the 7.5 tonne weight restriction on the C138 Hargham Road from a point 167 metres east of its junction with the U33043 Church Road to its junction with the U33088 The Green in the PARISH OF OLD BUCKENHAM (hereinafter referred to as the said road (c))
- 1. Save as provided in Article 2 of this Order and whereas the Norfolk County Council as Traffic Authority for the Administrative County of Norfolk is satisfied that:-
 - (i) carriageway resurfacing works are required at the said roads (a) (b) and (c) in the PARISHES OF QUIDENHAM AND OLD BUCKENHAM and:
 - (ii) that in consequence with effect between 07:00 and 19:00 hours from 18th March 2021 to 19th March 2021:
 - (a) traffic over the said road (a) should be prohibited; and
 - (b) a temporary suspension of the 7.5 tonne weight restriction be imposed on the said roads (b) and (c);

for the duration of the works expected to be about 2 days within the period.

- Nothing in Article 1 of this Order shall make it unlawful for a vehicle which requires access, to proceed to a final destination situated within the length of road specified in Article 1 of this Order.
- 3. This Order has a maximum duration of 18 months and will be revoked upon completion of the works. Where exceptional circumstances are encountered during the performance of the works specified in this Order the operational period of this Order may become extended to allow completion of the works after obtaining consent of the Secretary of State.

NOW THEREFORE the Norfolk County Council DO HEREBY ORDER, that with effect between 07:00 and 19:00 hours from 18th March 2021 to 19th March 2021 for the duration of the works the said road (a) SHALL NOT BE USED by any class of vehicle and the said roads (b) and (c) SHALL BE SUBJECT to the temporary suspension of the 7.5 tonne weight restriction.

Alternative route is via: Clockwise - C153 Hargham Road, C572 High Street, C572/B1077 Connaught Plain, B1077 Exchange Street/ Church Street/ Surrogate Street, Station Road, Buckenham Road, Attleborough Road/ The Green, C138 The Green/ Hargham Road/ Road From Snetterton To Old Buckenham Anti-Clockwise - C138 Road From Snetterton To Old Buckenham/ Hargham Road/ The Green, B1077 The Green/ Attleborough Road/ Buckenham Road/ Station Road/ Connaught Road/ Connaught Plain, C572 Connaught Plain/ High Street, C153 Hargham Road (Attleborough, Old Buckenham, Quidenham).

(If necessary the restriction could run for a maximum period of 18 months from the date of the Order).

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
