022.21) ANP Theme Sub-Committees Updates

- a) The Local Economy Updates Looking at additional employment land. Providing an economic strategy for the Town with Breckland. How to attract investment, promote local businesses and actively promote the Town. Need good representation from as many groups as possible for their input.
- b) Housing Cllr Tyrer will check with Breckland the status of the Design Guide provided by Consultant Liz Wrigley. A review was carried out regarding number of houses so need to establish if there are any changes that would affect us
- c) Transport & Communication There is progress being made with Broadband and it will get better. Integrated transport and car park strategy implementation plan being discussed with Breckland.
- d) Education Heads of Schools would be contacted to see if they can supply some input.
- e) Health & Social Care Elizabeth Burrows gave background information concerning AttCare. A survey had been carried out to identify health needs but was now out of date they need to raise £24,000 for an updated survey, although they have managed to raise £17,500 they hoped the Town Council would match fund Breckland donation of £5,000. It was suggested to resurrect Attleborough Matters to keep people updated.
- f) Sports & Community Facilities The Indoor Sports Centre to be taken forward there is money available through S106, looking at two options setting out an initial project plan is progressing. London Road play area, money allocated, design put forward, consultation needed and will organise shortly. St Marys church expanding their hall for a music centre. Old Library site need to evaluate how we can utilise for the benefit of the community.
- g) Environment, Sustainability and Design Quality Cllr Taylor and Cllr Grave would like to be involved.
- <u>023.21) ANP Projects</u> Cllr Tyrer will produce a draft by end of this week which will illustrate projects and what has been happening over last few months **ACTION: ET**

District Councillors will decide who becomes their representative to attend committee meetings.

- <u>026.21) Community Involvement</u> In discussion regarding Attleborough Matters. Cllr Grave looking at website. The Town could have a youth council to feed into this and have their say, Cllr Taylor suggested keeping an open mind when choosing a representative for this.

A) Cllr Tyrer replied all highways issues are dealt with by County Council who are the Highway authority, I will be attending a meeting in February with Breckland and will bring to their attention but I am not aware of any plans at the moment.

Also raised the need to widen the junction at Mill Lane, flooding at Besthorpe and the importance of progressing the Linear Park.
