COUNCILLOR CO-OPTION PROCEDURE

Town councils are permitted to co-opt a qualifying person on to the Council to fill a vacancy when the requirements to hold an election have not been met. To ensure the open and transparent co-option of Councillors the following procedure will be followed.

- Attleborough Town Council will advertise councillor vacancies on its website and social media.
 The Mayor of the Council, or Chair of the meeting if the Mayor of the Council is unavailable, will
 announce vacancies in a Full Town Council meeting.
- 2. Interested candidates who are eligible to stand as a Councillor are invited to send an email to enquiries@attleboroughtc.org.uk by a specified date of no less than 3 weeks from the announcement. This email should include:
 - The reason for them wishing to be a Councillor.
 - b. Previous community, council, educational, work, or vocational experience;
 - Other skills they can bring to the Council; and
 - d. Contact information (Please note councillors are required to have a means of contact by telephone and/or email publicly listed, and these emails will form part of a meeting pack prior to the meeting at which a Town Councillor is to be co-opted).
- 3. At the following Full Town Council meeting (after the deadline noted in point 2) candidates are invited to publicly say something about themselves. Each candidate will be allocated a maximum of 5 minutes. Councillors will be given an opportunity to ask the candidates questions before voting takes place. If there are a significant number of candidates, the Town Council may call an Extraordinary Full Council meeting to allow time for this process.
- 4. The Chair of the meeting will request the Councillors present to nominate any of the candidates. Candidates will require a proposer and seconder to progress to the voting stage. If there is only one vacancy, a Councillor may only nominate or second one candidate. One candidate needs to receive an absolute majority of votes to become a Councillor.
- 5. The Chair of the meeting will then place the names of those nominated into alphabetical order and proceed to vote. Councillors will have one vote per vacancy to be filled. Voting will be by a show of hands and will continue until one candidate has received an absolute majority of those Councillor's present. At this stage, the successful candidate will be declared co-opted. Should no single candidate receive a majority on the first vote, the candidate with the lowest number of votes is eliminated. Voting will then take place for the remaining candidates until one person receives an absolute majority.
- The successful candidate is then declared co-opted to the Town Council and will be asked to join
 the meeting as a Councillor. The successful candidate is a Councillor in their own right and is no
 different to any other member; co-option is a legitimate form of election as part of the election
 process.

Notes of Residents' Questions

The Chairman read out questions, previously submitted and responded as below: -

It was agreed in the 2nd Public Participation to provide to list the full questions sent to the council as some had only been particularly raised in the meeting. See below:

Question 1

I am particularly concerned about what I read / see regarding the judicial review the Town Council is facing. Of course, what we read and see can be very different to the reality, especially in legal cases where it is hard to be open.

When I first heard that the Town Council were taking action against two Councillors without any decision of the District that they had breached the Code of Conduct, I was quite bemused; after all, the case law (Honiton, Ledbury) has established the dubious nature of doing so.

Then it was suggested that the Town Council was being JR'd; therefore, surely, at pre-action stage, the Town Council would have realised the potential issue and conflict with case law and may have then backed down.

It seems to be the case that the Town Council are being advised by Anthony Collins solicitors. This particularly surprised me given Anthony Collins are pretty clear about the position; their own bulletin posted after Ledbury stated:

"Any local authority will be acting unlawfully if it tries to bypass the Code of Conduct procedure under the Localism Act 2011 when addressing alleged misconduct by councillors."

I appreciate all cases are different and have to be looked at in a fact sensitive way. It's also not unhelpful for such challenges to proceed as they can help to provide further clarity on the existing legal framework, which still leaves some unanswered questions. However, I must admit I am still left confused why the Town Council has continued to defend itself if it was the case that it wrongly removed Councillors?

A) The Judicial Review is still ongoing, the case has been conceded at the High Court, the Council conceded that it acted unlawfully, we are waiting for the ruling on costs.

Question 2

What are the chances of the community cars being restarted?

A) At the moment with the lockdown situation it isn't going to happen mostly because insurance purposes and the age of those volunteers raises health and safety issues, in the meantime through the Coronavirus Helpline 01953 686538 we have found another way of facilitating travel during this period at subsidised rates. For all involved in this you have done an amazing job coordinating everything.

Question 3

Question 1: With the recent termination of the Clerk/CEO's employment, did she receive any pay-off/financial settlement?

A) There was no financial settlement. Just to clarify it was not for financial irregularities, it was not to do with anything in that regard and no criminal action has been found.

Question 2: When is the Judicial review expected to come to an end?

A) We hope soon; however, we are waiting for a report.

When will the residents of Attleborough be briefed on the outcome and any subsequent next steps?

A) Finalising reports that will detail the circumstances relating to the Judicial Review, it will be released to the public as soon as we are legally able to do so but it has taken longer than anticipated.

With it being a Judicial Review, is it likely that there will be a final court hearing and will the residents of Attleborough be permitted to attend?

A) It isn't a public high court case it was conceded fairly early on

To date how much have ATC spent on the Judicial review?

A) Almost £50,000 before costs have been determined. As Chair of the Council, we owe the community a tremendous apology as well as the two councillors who has action taken against them. An official apology will be coming at the conclusion of the case.

Question 4

Is the vacancy for our Town Clerk being advertised as a Chief Executive Officer (CEO) role, which by definition gives the holder high level decision making authority? The Town Clerk role is one of support and advice to our elected Councillors. I know some other councils have done this but in view of our recent history it appears the residents of Attleborough are not happy with this. As a council now aspiring to be 'community led' this might be a good starting point.

A) We are seeking a new Town Clerk; it is a matter for the Personnel Committee to discuss at the conclusion of all matters necessary for us to advertise for a new Clerk

Question 5

- 1) Please could you explain the process for the annual election of the New Mayor as laid down in the Town Council's Terms of Reference.
- A) Standing orders are available but are being continually looked at. Following my election, it has been raised that Cllrs would like me to continue to see the transition of the Council through. I have agreed to stand but it will be a decision for Cllrs to elect and it is their right to elect who they want to.
- 2) Following on re procedure some people may view an 'abstain' vote as a form of protest or a show of no confidence so please could you explain the use of 'abstain' in your motion votes and if an explanation as to the reason for an 'abstain' vote is required.
- A) You can legally abstain for if you took no part in original meeting or a general feeling of neutrality and can't make a decision on how to vote. If you really object to something, then you should really vote that way and should not abstain.
