

**NORFOLK COUNTY COUNCIL
(ATTLEBOROUGH)
TEMPORARY TRAFFIC RESTRICTION ORDER 2021
ROAD TRAFFIC REGULATION ACT, 1984 SECTION 14(1)**

ORDER prohibiting the use by vehicles of the C153 Hargham Road from its junction with the C562 High Street for a distance of 7 metres southwards in the TOWN OF ATTLEBOROUGH.

1. Save as provided in Article 2 of this Order and whereas the Norfolk County Council as Traffic Authority for the Administrative County of Norfolk is satisfied that:-
 - (i) carriageway surfacing works are required at the C153 Hargham Road from its junction with the C562 High Street for a distance of 7 metres southwards in the TOWN OF ATTLEBOROUGH (hereinafter referred to as the said road) and:
 - (ii) that in consequence traffic over the said road should be prohibited with effect between 19:00 and 06:00 hours from 26th April 2021 to 1st May 2021 for the duration of the works expected to be about 5 nights within the period.
2. Nothing in Article 1 of this Order shall make it unlawful for a vehicle which requires access, to proceed to a final destination situated within the length of road specified in Article 1 of this Order.
3. This Order has a maximum duration of 18 months and will be revoked upon completion of the works. Where exceptional circumstances are encountered during the performance of the works specified in this Order the operational period of this Order may become extended to allow completion of the works after obtaining consent of the Secretary of State.

NOW THEREFORE the Norfolk County Council DO HEREBY ORDER, that with effect between 19:00 and 06:00 hours from 26th April 2021 to 1st May 2021 for the duration of the works the said road SHALL NOT BE USED by any class of vehicle.

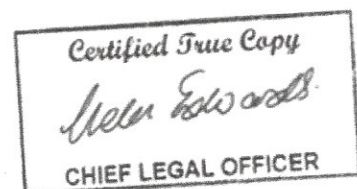

In the event of the start date being delayed the new start date will be displayed on site in advance.

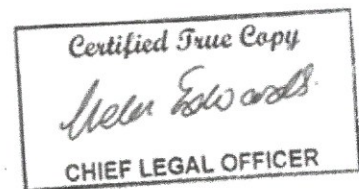

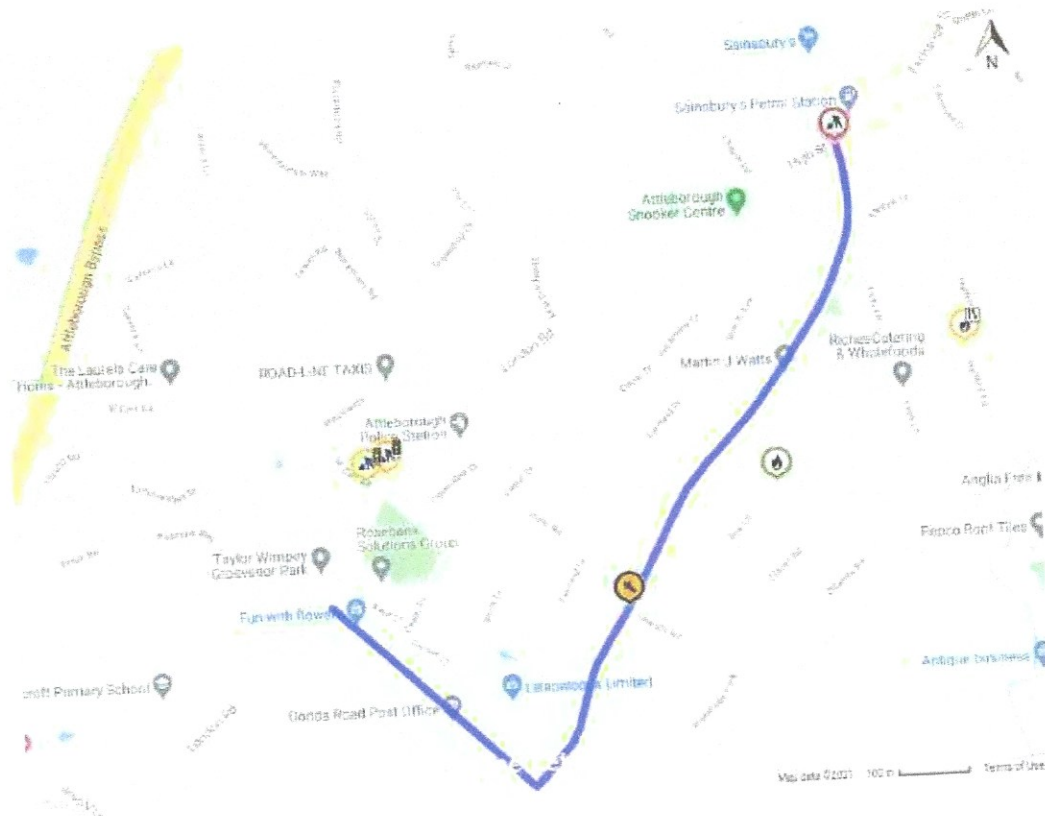
