# Minutes of the meeting of the Attleborough Town Council Held on Monday, 2<sup>nd</sup> August 2021 at 7.00 pm Held at the Town Hall, Queens Square.

<u>041.21) Mayors Welcome</u> – Cllr Leslie welcomed everyone to the meeting and said he had been at the well-attended event held on Queens Square on Saturday.

#### 043.21) Parish Poll Results -

- Cllr Leslie announced 58 people had voted in favour for 1<sup>st</sup> Question and 48 people had voted in favour for 2<sup>nd</sup> Question. This represented significantly less than 1% of the population but if the Parish Poll had taken place when it was called the turnout would have been significantly higher. There is no legal obligation for the Council to act on the result.
- After a discussion each Cllr stated whether they would or would not resign and
  explained their reasons. It was felt that if the majority of Cllrs resigned, there was no
  certainty the four remaining Cllrs would resign as well. It was better for Cllrs to stay
  and carry on progressing the Council forward than have it revert back. People vote
  with their feet if they are unhappy, the low turnout possibly meant residents were
  happy with the way the Council has progressed.
- Cllr Taylor stated Question 2 of the Poll reflected the Town was still unhappy and needed to be acknowledged and with the amount of public money spent there needed to be some level of accountability. It would be lawful for the Council to consider a Standards Complaint against those members that are accountable and a draft should be brought to the next meeting.

 On the first question Cllrs personal comments had been an indicative vote and no further proposal needed. On the second question Cllrs would review the Investigation Reports and Judicial Review.

On the motion of Cllr Taylor, seconded by Cllr Grave, it was

**RESOLVED** - No later than October meeting a Standards Complaint would be brought to the Council for consideration against those Cllrs who were in breach of the principles, on basis of information of the Judicial Review. 
