On the motion of Cllr MacKinnon, seconded by Cllr Dale, it was **RESOLVED** to approve the minutes of the meeting held 14<sup>th</sup> November 2022.

**079.22) Newsletter Spring Edition**

On the motion of Cllr Bond, seconded by Cllr Redfern, it was **RESOLVED** to give the Clerk the authority to investigate with the agreed printer (Solo Press) whether there was an option to do a combined print and postage at better value, and to proceed as necessary.

### **081.22) London Road Opening**

On the motion of Cllr Bond seconded by Cllr Lane, it was **RESOLVED** to budget £1000 for the Clerk to plan a Wheelpark grand opening, including investigating if this could be offered by the contractor.

### **083.22) Christmas Events**

Update given on community cinema and crafternoon which have good support. Cllr Lane asked that we share the St Marys "bring a friend" campaign. Discuss nominal charge for cinema going forward to prevent no shows.

### **084.22) Events Plan —**

On the motion of Cllr Lane, seconded by Cllr Redfern, it was **RESOLVED** to in principle agree the events schedule for next year.

Further discussion was had on the Wedding Fair and improvements to the venue. On the motion of Cllr Lane, seconded by Cllr Dale, it was **RESOLVED** to look into improvements to the ground floor of the Town hall to provide weddings and bring details in January. This would include access, curtains and kitchen.

### **085.22) Purchase of marquee, banners and sails-**

On the motion of Cllr Bond, seconded by Cllr Lane, it was **RESOLVED** that the clerk should purchase banner and sails to the value of £500.
