

**NORFOLK COUNTY COUNCIL (ATTLEBOROUGH, VARIOUS ROADS)  
PROPOSED TRAFFIC ORDER AND FOOTWAY/CYCLEWAY NOTICE 2023**

**The Norfolk County Council  
(Attleborough, C153 Hargham Road)  
(30 mph and 40mph Speed Limit) Amendment Order 2023**

The Norfolk County Council propose to make the above Order under the Road Traffic Regulation Act, 1984, the effect of which will be to prohibit any vehicle from exceeding the speeds specified below as follows:

- (1) 30 miles per hour along the length of road specified in Schedule 1 below; and
- (2) 40 miles per hour along the length of road specified in Schedule 2 below.

The existing length of the 30 miles per hour speed limit along the C153 Hargham Road would be extended by 85m requiring a reduction in the current length of 40 miles per hour speed limit The Norfolk County Council (Attleborough, Various Roads) (40 mph Speed Limit) Order 2013 and The Norfolk County Council (Attleborough, Various Roads) (30 m.p.h. Speed Limit) Consolidation Order 2019 would be amended respectively.

**Proposed 40mph Speed Limit**

C153 Hargham Road	-	From a point 160 metres south-west of its junction with the U11324 New Road south-westwards for distance of 632 metres.

Attleborough, U33124 New Road  
Footway Conversion To Cycleway/Footway Notice 2023**

The Norfolk County Council is proposing to convert lengths of existing footways to combined cycleway/footway using powers under Section 66(4) and Section 65(1) of the Highways Act 1980, on the U33124 New Road along the existing footway on the northern side of the carriageway from a point 95 metres west of its junction with the C153 Hargham Road westwards for a further distance of 135 metres to the existing shared use facility the Town of Attleborough.

The conversion will consist of widening the existing footways to construct a combined cycleways/footways 3.0 metres in width. Pedestrians and cyclists will have joint use and will not be segregated.

The reason for this proposal is to provide a safer route for cyclists.
